Lincoln County was created by the Wisconsin Legislature on March 4, 1874, with a population of 895, and land area of 2,750,000 acres. At that time Lincoln County included most of present day Oneida and Vilas Counties, as well as parts of present day Langlade, Taylor, Price and Iron Counties.
